**EXECUTIVE ORDER NO. 2000-38**

**RELATIVE TO ESTABLISHING A TASK FORCE TO  
PUBLISH THE FOURTH VOLUME OF THE HALE'-TA  
SERIES AS A TRIBUTE TO THE GENERATIONS OF  
FAMILIES IN PUBLIC SERVICE.**

**WHEREAS**, during calendar year 2000, surveys were sent to the Executive Branch departments and agencies asking employees to search for the generations of families in public service; and

**WHEREAS**, from these surveys, the second, third, and fourth generations of families in public service were recognized at the Organic Act Fiftieth Anniversary Celebration held on August 1, 2000; and

**WHEREAS**, it is desirable to memorialize in a more permanent fashion the accomplishments, contributions, and heritage of the generations of families who have dedicated their lives to public service and this can be done in the next Hale'-ta series of books of Guam heritage; and

**WHEREAS**, a fourth volume of the Hale'-ta series would receive wide distribution in the community and in educational institutions at the local and national level, thereby properly memorializing the accomplishments of the generations of families; and

**WHEREAS**, a fourth volume of the Hale'-ta series will preserve and maintain our Chamorro heritage of accomplishments, but also document the historical evolution of our government; and

**WHEREAS**, in order to further these ends, a task force is needed to publish the book and a registry of public servants; and


**NOW, THEREFORE, I, CARL T.C. GUTIERREZ, I Maga'Lahen Guåhan, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, do order:**

1. **Creation, name, and membership of task force.** A task force is created, to be known as the "Hale'-ta: Families in Public Service Task Force", consisting of individuals from the following:
  - a) Division of Research, Publication & Training, Department of Chamorro Affairs;
  - b) Guam Memorial Hospital Authority;
  - c) Richard A. Taitano Micronesia Area Research Center, University of Guam;
  - d) Learning Services Center, Guam Community College;
  - e) Director, Department of Administration;
  - f) Director, Government of Guam Retirement Fund;
  - g) Chairperson, Governor's Employee Recognition Program;



- h) Chairperson, Cultural and Heritage Committee, Guam Visitors Bureau;
  - i) Guam Legislature;
  - j) Guam Judiciary; and
  - k) GARP-SPIMA.
2. **Chairperson and Vice-Chairperson.** The Governor shall appoint a chairperson and a Vice-Chairperson of the task force.
  3. **Administrative Support.** The following departments and agencies shall work together to provide support for the task force: Department of Chamorro Affairs, Guam Memorial Hospital Authority, Governor's Employee Recognition Program, Guam Power Authority, Port Authority of Guam, Guam Waterworks Authority, Guam Telephone Authority, Department of Education, Department of Administration, Guam Visitors Bureau, and Office of the Governor. The support shall consist of office operations, staff, equipment, supplies and services for the Hale'-ta: Families in Public Service Task Force, and to carry out the intent and purpose of this Executive Order.
  4. **Duties of Task Force.** The Task Force shall:
    - a) undertake all efforts to accurately and informatively portray the Government of Guam workers with significant achievements, contributions, or family uniqueness in Volume 4 of the Hale'-ta Series.
    - b) publish a registry for the generations of families in public service.
    - c) Name and oversee the progress of the subcommittees appointed by the chairperson, as necessary.
  5. **Funding.** Other than administrative support expenses, the funding for the publication expenses of this book may come from private-public partnerships, employee fundraising activities, direct sponsorships from public or private sources, or direct sales to government of Guam employee associations, community organizations, publishing houses, book stores, or other retail outlets. The direct sales activities shall be under the control of the Division of Research, Publication & Training, Department of Chamorro Affairs.
  6. **Net Revenue.** After publication expenses are paid, any net revenue from the initial sales and future sales of the Volume 4 of the Hale'-ta Series shall be transferred to the Governor's Employee Recognition Program and shall be immediately available for present and future employee recognition programs.
