**EXECUTIVE ORDER NO. 2002-13**

**RELATIVE TO CREATING TASK FORCES TO SUPPORT  
THE MISSIONS OF THE GUAM ANCESTRAL LANDS  
COMMISSION AND THE CHAMORRO LAND TRUST  
COMMISSION BY THE DEPARTMENT OF LAND  
MANAGEMENT.**

**WHEREAS**, the support provided by the FY2002 Budgets for the mission of the Guam Ancestral Lands Commission and the Chamorro Land Trust Commission has been short; and

**WHEREAS**, the Guam Ancestral Lands Commission and the Chamorro Land Trust Commission will need assistance and expertise to aggressively pursue their missions and to prepare and implement planning initiatives for the use of their properties; and

**WHEREAS**, the economy of Guam could be immensely helped by the implementation of their respective initiatives and accomplishment of their respective missions;

**NOW, THEREFORE, I, CARL T.C. GUTIERREZ**, I Maga'Lahen Guåhan, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, do order the following:

**1. Creation of Task Forces.**

**A. DLM/CLTC Lease Recording Task Force.** A task force is hereby created, consisting of the Administrative Director of the Chamorro Land Trust Commission, the Division Heads of the Agriculture Section and the Residential Section of the CLTC, the Division Head of the Date Processing Division of the CLTC, and the Deputy Civil Registrar of the Department of Land Management.

**Duties of task force.** The DLM/CLTC Lease Recording Task Force is directed to facilitate the preparation and the recording of all Chamorro Land Trust Leases and Licenses issued by the Chamorro Land Trust Commission with the Records Division of the Department of Land Management. To prepare a report to the Governor of the results within 140 days from the date of this Executive Order.

**B. DLM/CLTC Pre-Occupying Lease Signing Task Force.** A task force is created, consisting of the Director of the Department of Land Management, the Administrative Director of the Chamorro Land Trust Commission, the Division Head of the Land Administration Division of DLM, and the Division Heads of the Agriculture Section, the Residential Section, and the Data Processing Division of the CLTC.




**Duties of task force.** The DLM/CLTC Pre-Occupying Lease Signing Task Force is directed to facilitate the preparation and the signing of leases for qualified applicants pre-occupying Chamorro Land Trust properties. To refer those signed leases to the DLM/CLTC Lease Recording Task Force for recording with the Department of Land Management Records Division. To prepare a report to the Governor of the results every 30 days from the date of this Executive Order.

- C. DLM/GALC Applications, Hearings and Deed Task Force.** A task force is created, consisting of the Executive Director of the Guam Ancestral Land Commission, the Director of Land Management, the Division head and staff of the Land Administration Division of DLM.

**Duties of task force.** The DLM/CLTC Applications, Hearing and Deeds Task Force is directed to review applications, prepare applications for title hearing and prepare deeds for signing. To refer those signed deeds to the DLM/CLTC Lease Recording Task Force for recording with the Department of Land Management Records Division. To prepare a report to the Governor of the results every 30 days from the date of this Executive Order.
