**EXECUTIVE ORDER NO. 2004- 27**

**RELATIVE TO ADOPTING THE DEPARTMENT OF ADMINISTRATION'S PERSONNEL RULES AND REGULATIONS FOR IMMEDIATE IMPLEMENTATION BY THE GUAM ECONOMIC DEVELOPMENT AND COMMERCE AUTHORITY AS INTERIM POLICY GOVERNING THE RIGHTS, CONDUCT, AND OBLIGATIONS OF EMPLOYEES AND RESPONSIBILITIES AND ACTIONS OF MANAGEMENT**

**WHEREAS**, Governor Felix P. Camacho and Lieutenant Governor Kaleo S. Moylan are committed to a merit system of personnel administration in the government of Guam; and

**WHEREAS**, *Title 4, Guam Code Annotated, Section 4105* provides that rules concerning the Executive Branch shall take effect upon approval by the Civil Service Commission, by Executive Order of the Governor and filing with the Legislative Secretary; and

**WHEREAS**, the Guam Economic Development and Commerce Authority's Personnel Rules and Regulations was last adopted in 1993; and

**WHEREAS**, *Title 12, Guam Code Annotated, Section 50106* provides that the GEDCA Administrator shall be directly responsible to the Board for the day-to-day operation of the Authority and shall administer its programs and policies; and

**WHEREAS**, *Title 12, Guam Code Annotated, Section 50117* provides that the GEDCA Board of Directors shall create rules and regulations for the Authority governing the functions and operations of the Authority; and

**WHEREAS**, the Department of Administration Personnel Rules and Regulations is in compliance with federal personnel management laws applicable to the territory of Guam, such as the Americans with Disabilities Act, Fair Labor Standards Act, Family Medical Leave Act, Drug-Free Workplace Program, and other pertinent laws; and

**WHEREAS**, the Civil Service Commission approved the Department of Administration Personnel Rules and Regulations in its meeting on the 12<sup>th</sup> day of December 1995, and after further review and revisions, the Civil Service Commission further approved the revisions on August 1, 1996; and

**WHEREAS**, the Department of Administration Personnel Rules and Regulations, adopted by the Director of Administration and approved by the Civil Service Commission was subsequently signed and promulgated by *Executive Order No. 96-24*; and

**WHEREAS**, the Executive Order No. 96-24, Para 3, states in part "*Unless contrary to statute, all autonomous departments and agencies are hereby required to adopt the*
