**RELATIVE TO AMENDING THE ATTACHMENT OF EXECUTIVE  
ORDER 2007-12 WHICH ESTABLISHED THE TEAM GUAM T4**

WHEREAS, on September 12, 2006, Executive Order 2007-12 established TEAM GUAM T4 to coordinate, facilitate and prepare Guam for the United States Department of Homeland Security National-Level Exercise, Top Officials 4 ("TOPOFF 4"), and

WHEREAS, TOPOFF 4 commenced on Monday, the 15<sup>th</sup> day of October through Wednesday, the 24<sup>th</sup> day of October, 2007; and


WHEREAS, the Exhibit A of the Executive Order 2007-12 listed the task force representatives known at the time of the Executive Order; and

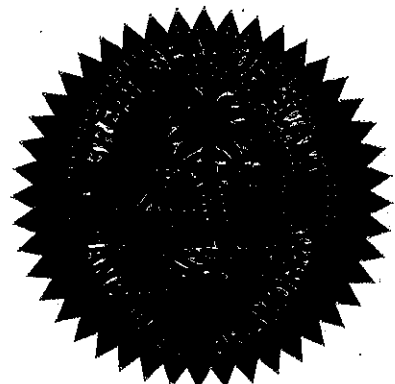
The Amended Exhibit A attached hereto as Exhibit A-1 supersedes and replaces the Exhibit A of Executive Order No. 2007-12.
