

NAVAL GOVERNMENT OF GUAM

Executive Order Number 16-47

TO WHOM IT MAY CONCERN:

Proclamation 1-47 issued by the Governor of Guam made provision for the establishment of Civil Government Reservations within the limits of presently proposed post-war military reservations and areas. It placed the laws of the Island of Guam in full force and effect within such Civil Government Reservations.

Executive Order Number 9-47 amended Section 653 of the Penal Code of Guam to permit the sale of alcoholic beverages to civilians other than Guamanians and established certain regulations covering methods of sale.

It is anticipated that the Guamanians through the Guam Congress may exercise the option of establishing a different method of distributing alcoholic beverages than that which may be found desirable in the Civil Government Reservations.

In order that the distribution of goods and services within Civil Government Reservations may not interfere with or intrude upon the Guamanian private enterprise structure, and

In order that the system of alcoholic beverage distribution within the Civil Government Reservations may not interfere or conflict with the distribution system selected by the Guamanians for themselves.

Concessionaires and others granted licenses to engage in the distribution of goods and services within Civil Government Reservations will confine their activities to serving the residents of the particular reservation designated on the license, and the license will so state.

Importations of alcoholic beverages and other commodities will be limited to quantities required by the licensee for the supply of the residents of the Civil Government Reservation in which he is licensed to do business.

Licenses to engage in distribution of goods and services or to import alcoholic beverages or other commodities will not be issued to a concessionaire for operation within a Civil Government Reservation until that Reservation has been established and its limits defined in accordance with the procedure set forth in Proclamation 1-47.

When a Civil Government Reservation has been established by proper authority, it is anticipated that concession may be granted for the sale and distribution of goods and services to the residents of, and within the boundaries of, the particular reservation for which the concession is granted. Applicants for the licenses needed to engage in the activities of a concessionaire shall address applications to the Governor of Guam. Such applications shall bear endorsements of the manager of the camp in which the Civil Government Reservation is located and of the military authority having cognizance over the military Reservation in which the Civil Government Reservation is located.

Nonprofit clubs may be organized to apply for concessions within Civil Government Reservations.


Applicants for concessions are requested to provide the following information in their applications to the Governor of Guam:

- (a) Full names, address and citizenship of the corporation, partnership, club or individual applying for concessionaire licenses.
- (b) Location of the Civil Government Reservation in which the applicant desires to operate a concession.
- (c) Complete description of the activities in which the applicant proposes to engage.
