EXECUTIVE ORDER NO. 8 -58

WHEREAS, the Guam Omnibus Act (Public Law 896, 84th Congress) extended to Guam the benefits of the Public Health Service Act (Public Law 410, 78th Congress); and

WHEREAS, the Guam Plan to effectuate the purposes of the Public Health Service Act has been approved by the Surgeon General of the United States; and

WHEREAS, pursuant to Section 814 of the Public Health Service Act (42 U.S.C. 846), and appropriations for the United States Department of Health, Education and Welfare, funds have been allotted to Guam for Tuberculosis Control, General Health, Mental Health, Heart Disease Control, and Cancer Control; and

WHEREAS, the sum of \$21,825 has been received as the initial payment of funds so allotted for expenditure pursuant to the Guam Plan;

NOW, THEREFORE, pursuant to the authority vested in me by Section 6(b) of the Organic Act, it is hereby ordered and directed as follows:

1. A special fund to be known as the Public Health Services Grant Fund, hereinafter referred to as the "Fund" is hereby established to account for Federal funds paid to Guam for expenditure under the Guam Plan.
2. A separate account shall be established within the Fund for each grant category for which Federal funds are allotted.
3. The Fund shall consist of such sums as have been or shall be allotted to Guam, and matching funds hereby directed to be allotted from any appropriation for the operation of the Department of Medical Services, in the ratio of one dollar for each dollar of the Federal allotment for Tuberculosis Control, and one dollar for each two dollars of the Federal allotments for General Health, Mental Health, Heart Disease Control, and Cancer Control.

4. The Fund shall be expended only for the purposes set forth in the Guam Plan as approved, or as it may hereafter be amended with the approval of the Surgeon General of the United States. Disbursement shall be made on vouchers certified by the Director of Medical Services.

5. The Director of Finance shall prescribe such procedures as may be necessary to properly account for the Fund, not inconsistent with the requirements of the Public Health Service of the United States Department of Health, Education and Welfare. Records and accounts pertaining to the Fund shall be maintained by the Department of Finance.
