EXECUTIVE ORDER NO. 61-18

DESIGNATION OF GOVERNOR'S RESIDENCE AS "THE GOVERNOR'S PALACE"

WHEREAS, the official residence of the Governor of Guam has in recent years been referred to as "Government House"; and

WHEREAS, for hundreds of years under the Spanish regime the residence of the Governor was known as the "Palasyo", the English equivalent of which is "Palace"; and


WHEREAS, under American rule in the years after 1898 the residence of the Governor was appropriately called, in the English translation, "The Governor's Palace"; and

WHEREAS, the Sixth Guam Legislature on June 22, 1961, unanimously adopted Resolution No. 184, setting forth the historical background of the name of the Governor's residence; and


WHEREAS, Resolution No. 184 further designates the present residence of the Governor, constructed under the territorial government, as "The Governor's Palace";

NOW, THEREFORE, pursuant to the authority vested in me by the Organic Act of Guam, and more particularly Section 6(b) thereof, it is hereby ordered that the official residence of the Governor of Guam, presently known as "Government House", is hereby designated "The Governor's Palace", and all future reference thereto shall be made accordingly.

EXECUTIVE ORDER NO. 61-25

ECONOMIC DEVELOPMENT COMMISSION;  
INCREASE OF MEMBERSHIP FROM FIVE TO FIFTEEN


WHEREAS, Executive Order No. 61-22, issued on October 4, 1961, establishes an Economic Development Commission for the Territory of Guam, consisting of five members appointed by the Governor; and

WHEREAS, the broad scope of the functions of the Commission requires a larger membership in order that it can effectively carry out its responsibilities; and

WHEREAS, a wider representation from various groups and organizations would also contribute to the success of the Commission's work;

NOW, THEREFORE, pursuant to my authority under Section 7 of the Organic Act of Guam, it is hereby ordered that the membership of the Economic Development Commission be increased from five to fifteen, and Paragraph No. 1, of Executive Order No. 61-22, is amended accordingly.
