GOVERNING SCHOLARSHIPS AND STUDENT LOANS


WHEREAS, Section 11812, Government Code of Guam, authorizes the Board of Education to make regulations governing student loans, scholarships, and grants for transportation in connection therewith; and

WHEREAS, The aforesaid Section 11813, Government Code of Guam, provides that such regulations shall be subject to approval by the Governor, and shall be promulgated by Executive Order; and


WHEREAS, Executive Order No. 16-59 approved and promulgated Rules and Regulations Governing Scholarships and Student Loans;

AMENDMENTS TO REGULATIONS
GOVERNING SCHOLARSHIPS AND STUDENT LOANS

The following provisions of the Regulations Governing Scholarships and Student Loans adopted by the Board of Education on September 8, 1959, pursuant to Chapter 9, Title XII, Government Code of Guam, and approved and promulgated by Executive Order No. 16-59, have been amended by the Board of Education as of the dates indicated, as follows:

Paragraph immediately following Subsection 3.2(c):

"In addition the Board may provide, on the basis of financial necessity, grants to apply to or cover the cost of transportation to the college and return to Guam upon completion of studies. No application for a grant for return transportation will be considered prior to the final year of schooling."

(Deleted July 27, 1963)

Subsection 3.2(d):

"(d) Initial transportation to the institution."

(Added July 27, 1963)

Paragraph immediately following Subsection 4.4(c):

"In addition the Board may provide, on the basis of financial necessity, grants to apply to or cover the cost of transportation to the college and return to Guam upon completion of studies. No application for a grant for return transportation will be considered prior to the final year of schooling."

(Deleted July 27, 1963)

Subsection 4.4(d):

"(d) Initial transportation to the institution."

(Added July 27, 1963)

Subsection 4.5(f):

"(f) Have a grade point average of not less than 3.0, or present evidence of having been accepted by an accredited college, university, or technical school in the United States or its territories."

(Amended July 27, 1963)

Subsection 5.3(c):

"(c) In no case shall the total loaned any single student exceed \$6,000.00."

(Amended July 27, 1963)

Subsection 5.4(e):

"(e) Any full time student, on regular status and having a grade average at time of application of not less than "C", in financial need, and a bona fide resident of Guam, attending an accredited college, university or technical school in the United States or its territories, is deemed qualified."

(Added July 27, 1963)

NOTE: Items following 5.4(e) have been relettered so as to read as follows:

(f), (g), (h), (i), (j), (k), (l).

The terms, "Territorial" and "Territorial College," when used to identify the local college, have been deleted throughout the regulations and the term, "College of Guam," has been inserted, instead.

The foregoing amendments to the regulations were duly adopted by the Board of Education on dates indicated, and in certification thereof the undersigned has affixed his signature thereto.
