EXECUTIVE ORDER NO. 70-35

AMENDMENT OF EXECUTIVE ORDER 70-14:
FAMILY DAY CARE HOMES

WHEREAS, due to the steady rise in the cost of living, it is necessary to increase the fees for family day care home services; and

WHEREAS, such increased fees would be beneficial both to the children involved and the family day care parents.

NOW, THEREFORE, pursuant to the authority vested in me by the Organic Act of Guam and Section 9102, Government Code of Guam, it is ordered as follows:

1. A new Subsection C is hereby added to Section III of "Social Services Rules and Regulations No. 5" attached to Executive Order 70-14, to read:

(C) FAMILY DAY CARE HOMES FEES

The monthly rates for Family Day Care Homes are as follows:

5	250


2. This order shall be effective December 1, 1970.
