EXECUTIVE ORDER NO. 70-5

RECREATION COMMISSION OF GUAM--
AGANA SWIMMING POOL COMPLEX

WHEREAS, the Agana Swimming Pool Complex will in the near future be ready for use; and

WHEREAS, this new addition to the recreational facilities open to the public shall need administration and management; and

WHEREAS, the Recreation Commission of Guam is charged by law to conduct and operate recreational programs in all fields of athletic activities suitable to Guam;


NOW, THEREFORE, I, Carlos G. Camacho, Governor of Guam, by virtue of the authority vested in me by Section 26004, Government Code of Guam and the Organic Act of Guam do order as follows:

1. The Recreation Commission of Guam shall have jurisdiction and control over the operation and maintenance of the Agana Swimming Pool Complex.


2. The Recreation Commission of Guam shall have jurisdiction and control over any similar public facility hereafter constructed.

3. This order shall be effective this date.

EXECUTIVE ORDER NO. 70-4

TERRITORIAL BANKING CODE COMMISSION

WHEREAS, the laws of Guam dealing with banks and banking are limited; and

WHEREAS, as a consequence we must rely for control over such activities through Federal Statutes and regulations or upon laws of states in the case of a state bank; and

WHEREAS, the number of banks as well as banking activity has increased greatly in recent years as a result of our expanding economy; and

WHEREAS, it might be timely to enact a comprehensive Banking Code to bring our laws on the subject up to date; and

WHEREAS, it would be useful to have a study made of the entire field of banking practices so as to determine the desirability or necessity for a Banking Code.

NOW, THEREFORE, I, Carlos G. Camacho, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, do hereby order as follows:

1. The Territorial Banking Code Commission is hereby established to be composed of seven members whom I shall appoint and one of whom I shall designate chairman. The Commission shall meet at the call of the chairman for the purposes aforesaid and shall make its final report to the Governor no later than December 31, 1970, at which time the Commission shall dissolve.

2. All Departments and Agencies of the government shall cooperate to aid the Commission in its studies.


3. The Department of Revenue and Taxation shall furnish logistic support for the Commission.

4. This order shall be effective this date.
