EXECUTIVE ORDER NO. 74-13

COMPREHENSIVE MANPOWER PLANNING COUNCIL AND RELATED
MATTERS TO IMPLEMENT P.L. 93-203

WHEREAS, the purpose of the "Comprehensive Employment and Training Act of 1973" (CETA) is to provide public training and employment opportunities for economically disadvantaged, unemployed and underemployed persons, and to assure that training and other services lead to maximum employment opportunities and enhance self-sufficiency by establishing a flexible and decentralized system of Federal, state, and local programs; and

WHEREAS, the CETA, Section 3(c) repealed the Manpower Development and Training Act of 1962 and the Economic Opportunity Act of 1964; and

WHEREAS, Section 101 of CETA establishes a program to provide comprehensive manpower services throughout the nation; and

WHEREAS, Section 201 of CETA proposes to provide unemployed and underemployed persons with transitional employment in jobs providing needed public services in areas of substantial unemployment; and

WHEREAS, CETA provides for additional programs under Title III and IV of the Act; and

WHEREAS, the Government of Guam has signed its notice of intent to apply for prime sponsor pursuant to Title I, Section 102 (a)(2) and has been designated as prime sponsor charged with the responsibility of designing and carrying out a comprehensive manpower plan under Title I of CETA; and

WHEREAS, Section 104 of CETA requires the prime sponsor to establish a manpower planning council; and

WHEREAS, it is the desire and intent of the Government of Guam as prime sponsor to ensure that all Federal and local manpower programs in and for the Territory of Guam are planned and administered efficiently and effectively in order to provide manpower services, employment and training for the people of Guam;

NOW, THEREFORE, I, Carlos G. Camacho, Governor of Guam do hereby order and direct that:



1. The Guam Comprehensive Manpower Planning Council's function shall be to submit recommendations regarding program plans and basic goals, policies, and procedures, to monitor and provide for objective evaluations of employment and training programs conducted in the prime sponsorship area, and to provide for continuing analyses of needs for employment, training, and related services in such area. Any final decision with respect to such recommendations shall be made by the prime sponsor.
2. The Guam Manpower Planning Council will consist of 16 members. These members shall be as enumerated below and shall represent the organization and interests specified:
Staff Officer for Manpower Resources Development, Governor's Office
Director of Labor, Department of Labor
Supervisor-in-Charge, Human Resources, Department of Labor
Director of Education, Department of Education
Associate Superintendent, Vocational Education
Director, Department of Public Health and Social Services
Executive Director, Community Action Agency
Chief, Division of Vocational Rehabilitation
Chairman, Industrial Relations Council
President, University of Guam
Personnel Director, Jones and Guerrero Company
Executive Director, Guam Employers Council
President, Guam Contractors Association
Manager, Guam Continental Hotel
Assistant District Representative, Operating Engineers Local Union No. 3
Director of Agriculture, Department of Agriculture
3. All Government of Guam agencies within the Territory of Guam that have or are developing manpower programs are hereby directed to present their program proposals to the Guam Manpower Planning Council for their review and recommendation. After approval they are to be included in the annual Guam Comprehensive Manpower Plan or as an


amendment to the plan. All such program proposals must be reviewed and recommendations approved by the Governor prior to their submittal for funding.

4. The Staff Officer of the Governor for Manpower Resources Development shall be appointed by the Governor as Chairman of the Manpower Planning Council to serve at the pleasure of the Governor. The Director of Labor shall act as Chairman in the absence of the appointed chairman. All other members will also serve at the pleasure of the Governor.
5. The Chairman of the Guam Manpower Planning Council shall have the responsibility of establishing appropriate subcommittees as may be necessary to carry out the functions of the Manpower Planning Council.
6. The Manpower Planning Council shall meet at the call of the Chairman, but at least once each month. The Governor's Office of Manpower Resources Development shall provide secretarial services and staff for said council.
7. The Chairman of the Manpower Planning Council shall make such recommendations as may be necessary to further implement P. L. 93-203 including recommendations to establish a Manpower Services Council under Section 107 of Title I of the Comprehensive Employment and Training Act of 1973, or that the Manpower Planning Council be designated to act as a Manpower Services Council under Section 107 of the Comprehensive Employment and Training Act in addition to its functions under Section 104.
