of Guam; and


WHEREAS, the change of the effective date of transfer of activities

This request is being made per the attached memorandum from Director Jose Barcinas to the undersigned.

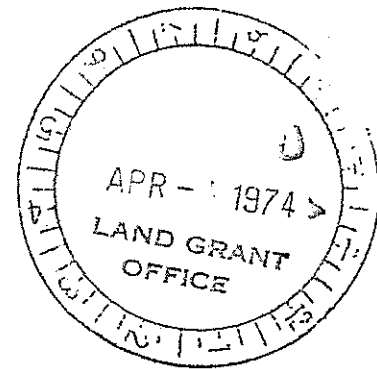

Subject: Transfer of Department Extension Service Personnel

This has reference to our memorandum of January 17, proposing conditional transfer of the following personnel from the Department of Agriculture to the University of Guam Land Grant Program:

2. Mrs. Lorraine M. Aguon	Home Agent Supervisor	Agricultural Extension Agent IV (Home Economics) PR-30, \$11,440
3. Mr. Thomas C. Crisostomo	Agricultural Extension Agent II	Agricultural Extension Agent IV, PR-30 \$11,440

Agriculture's original proposal to effectuate the above reassigned position titles and pay range assignments to the respective incumbents before permanently transferring them to the Land Grant Program was stalemated by the uncertainty of our FY 1974 budgetary funding level. As a result of this, Agriculture has ruled out any possibility of implementing the approved new pay range assignments for fiscal year 1974. Funds

necessary to carry through the salaries and personal benefits of subject employees to FY 1974 are even considered inadequate.

In view of limited funds, Agriculture urgently requests that the above-mentioned personnel be officially absorbed under the payroll of your newly reorganized College of Agriculture and Life Sciences.

It is further requested that transfer proceedings be initiated by your office at the earliest possible time, preferably before May 4, 1974.

Your immediate attention to subject request will be greatly appreciated.

EXECUTIVE ORDER NO. 74-24

ALL EXTENSION EDUCATION ACTIVITIES AT THE DEPARTMENT OF AGRICULTURE PURSUANT TO ONGOING FEDERALLY ASSISTED PROJECTS ARE TO BE ADMINISTERED BY THE UNIVERSITY OF GUAM.

WHEREAS, the University of Guam was established by the Government of Guam as the institution responsible for the conduct of higher education in the territory of Guam; and

WHEREAS, the United States Congress on June 23, 1972 enacted Public Law 92-318 designating the University of Guam as a Land Grant institution and may benefit from educational programs of the United States Department of Agriculture; and

WHEREAS, the University of Guam as a Land Grant institution is entrusted with the responsibility of administering all United States Department of Agriculture educational programs in the field of agriculture, home economics and related fields thereto; and


WHEREAS, for purposes of the above, the University of Guam has entered into a memorandum of understanding with the United States Department of Agriculture for the establishment of a Cooperative Extension Service to be administered by the University of Guam; and

WHEREAS, pursuant to the above, the University of Guam has established an administrative division known as the Guam Cooperative Extension Service under the College of Agriculture and Life Sciences for the management and conduct of all cooperative extension work in agriculture, home economics and related fields, and the administration of any and all funds it may receive for such work from appropriation made by the United States Congress, the Guam Legislature or any other sources;

NOW, THEREFORE, in order to obtain maximum benefits from federal programs applicable to Guam under the Land Grant Acts and ensure the economy and efficiency in the implementation and execution of educational programs in the territory of Guam, I, Carlos G. Camacho, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam and the Laws of Guam,

do hereby order that the Department of Agriculture extension activities and functions in the field of agriculture, home economics and subjects related thereto, including the personnel--their respective position titles and position numbers--engaged in the aforesaid activities, are hereby transferred to the University of Guam, effective upon the date of this order.
