EXECUTIVE ORDER NO. 76-20

WATER AND SEWER RATE SCHEDULE

WHEREAS, Section 21003 of the Government Code of Guam states that the functions of the Board on Utility Rates "shall be to formulate, establish, and publish, and from time to time review and where necessary revise, subject to the approval of the Governor by Executive Order, fair and reasonable schedules, uniform as to classes, of public utility rates including all related service, meter and other applicable charges for all public utility services furnished by the government of Guam...."; and

WHEREAS, Section 21005 of the Government Code of Guam states that:

"Before adopting any schedule increasing rates, the Board shall hold at least one (1) public hearing thereon...."; and

WHEREAS, the Board on Utility Rates did comply with Section 21005, did conduct public hearings at the Tamuning Elementary Cafetorium on April 12, 1976, and the Yona Elementary Cafetorium on May 4, 1976;

NOW, THEREFORE, I, RICARDO J. BORDALLO, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, and Section 21003 of the Government Code of Guam, do hereby approve and order that the following rate schedule for water and sewer be implemented effective August 1, 1976:

RATES FOR WATER AND SEWER

2. Guarantee deposit is based on an average month's charges for all the type of service and size of meter connected as established by the Board of Utility Rates:

3. Installation charge is based on the cost of service installation as established by the Board of Utility Rates as follows:

3.1 Meter installation charges and distances from main

\*Charge will be based on costs to be paid prior to installation.

3.2 Where it is necessary to cross streets or highways in making service installations, the extra costs for such crossings including paving repairs will be added to the charges under 3.1 above.

3.2.1 This charge will be collected in advance on an estimated basis subject to refund or additional charge when each job is completed. Service installation charges are collected from customers and are not refundable.

4. All water service shall be provided with a water meter and monthly charges will be according to the registration read.

5. Water rate:

A. For residential, commercial and government customers:

First 5,000 gallons - minimum

Next 15,000 gallons - \$.90/1,000 gallons

Excess 20,000 gallons - \$.80/1,000 gallons

6. Sewer rate:


A. Residential - \$5.00 per month per single family dwelling unit

B. Others - \$.40 per 1,000 gallons of metered water  
Minimum monthly charge - \$5.00

C. Privately-owned sewer truck discharging wastewater to public sewer at designated points - \$5.00 per load

7. Sewer service connection (for every inspection) - \$10.00
