



EXECUTIVE ORDER NO. 75-46

EMPLOYMENT AND TRAINING PLANNING AND SERVICES COUNCIL
AND RELATED MATTERS TO IMPLEMENT P. L. 93-203

WHEREAS, the purpose of the "Comprehensive Employment and Training Act of 1973" (CETA) is to provide public training and employment opportunities for economically disadvantaged, unemployed and underemployed persons, and to assure that training and other services lead to maximum employment opportunities and enhance self-sufficiency by establishing a flexible and decentralized system of Federal, state, and local programs; and

WHEREAS, CETA, Section 3(c) repealed the Manpower Development and Training Act of 1962 and the Economic Opportunity Act of 1964; and

WHEREAS, Section 101 of CETA establishes a program to provide comprehensive employment and training services throughout the nation; and

WHEREAS, Section 201 of CETA proposes to provide unemployed and underemployed persons with transitional employment in jobs providing needed public services in areas of substantial unemployment; and

WHEREAS, CETA provides for additional programs under Titles III, IV, and VI of the Act; and

WHEREAS, in May, 1974, the Governor of Guam on behalf of the Government of Guam signed its notice of intent to apply as a prime sponsor pursuant to Title I, Section 102 (a) (2) and has been designated as prime sponsor charged with the responsibility of designing and carrying out a comprehensive employment and training plan under Title I of CETA; and

WHEREAS, Section 104 of CETA requires the prime sponsor to establish an employment and training planning and services council; and

ponsor to ensure that all Federal and local employment and training programs in and for the Territory of Guam are planned and administered efficiently and effectively in order to provide employment and training for the people of Guam;

WHEREAS, the U.S. Department of Labor has published revisions to the regulations for Titles I, II, VI and VII of the CETA law in the Federal Register on May 23, 1975 (Volume 40 Number 101).

1. The Employment and Training Planning and Services Council's function shall be to submit recommendations regarding program plans and basic goals, policies, and procedures, to monitor and provide for objective evaluations of employment and training programs conducted in the prime sponsorship area, and to provide for continuing analyses of needs for employment, training, and related services in such area. Any final decision with respect to such recommendations shall be made by the prime sponsor.

2. The Employment and Training Planning and Services Council shall consist of members as enumerated below, (and such other members as I shall from time to time appoint):

Chairman: Governor's Executive Assistant

Education and Training:

- 1 member - Advisory Council for Vocational Education
- 1 member - University of Guam
- 1 member - Secondary Education

Business and Industry:

- 1 member - Guam Chamber of Commerce
- 1 member - Guam Contractor's Association
- 1 member - Hotel Association

Labor Organizations:

- 1 member - Local Union No. 3
- 1 member - AFGJE
- 1 member - Guam Federation of Teachers

- 1 member - Commissioner Representing the Northern part of the Island
- 1 member - Commissioner Representing the Central part of the Island
- 1 member - Commissioner Representing the Southern part of the Island

Community Based Organizations:

- 1 member - United Protestant Church
- 1 member - Catholic Church

Other Segments of Population:

- 1 member - Veteran's Office
- 1 member - Youth Organization
- 1 member - Older People's Organization
- 1 member - Women's Organization

Government Employers/Employment Agency:


- 1 member - Personnel Office, Andersen Air Force Base
- 1 member - Consolidated Industrial Relations Office
- 1 member - Department of Administration, Government of Guam


3. The Employment and Training Planning and Services Council will make such recommendations as they deem necessary or appropriate to implement P. L. 93-203 and rules and regulations promulgated thereunder.
4. The Chairman of the Employment and Training Planning and Services Council shall have the responsibility of establishing appropriate sub-committees as may be necessary to carry out the functions of the Employment and Training Planning and Services Council.
5. The Employment and Training Planning and Services Council shall meet at least once every other month. The Department of Labor shall provide secretarial service and such other supportive services as needed.
