EXECUTIVE ORDER NO. 77-27

COLLECTION OF FEES BY THE DEPARTMENT OF PUBLIC HEALTH  
AND SOCIAL SERVICES

WHEREAS, the Department of Public Health and Social Services provides a multitude of health and health-related services to the people of Guam; and

WHEREAS, some of these services have been established to meet the needs of a special group of persons or businesses; and

WHEREAS, these special services are being supported by all taxpayers in Guam; and

WHEREAS, those persons or businesses receiving these special services should be willing to help support those programs for which they receive the benefits; and

WHEREAS, all fees so established shall be approved by the Governor's Ad Hoc Committee on Government Revenues; and

WHEREAS, all monies collected shall revert to the General Fund of the Government of Guam;

NOW, THEREFORE, I, RICARDO J. BORDALLO, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, do hereby authorize the Director of Public Health and Social Services to charge and collect fees as follows:

1. Physical Examinations for Aliens as Required by the U.S. Immigration Service ..... \$40.00 each
2. Travelers Immunizations ..... 5.00 each
3. Duplication of Medical Records .... .07 per page  
Medical Summaries ..... 5.00 each
4. De-ratting Inspection and Issuance of Certificate, as follows:


This order shall be effective upon approval of the Governor and upon filing of said Order with the Legislative Secretary of the Guam Legislature.
