EXECUTIVE ORDER NO. 86- 10

DEPARTMENT OF REVENUE AND TAXATION
RULES AND REGULATIONS AFFECTING THE FEE
FOR VEHICLE INSPECTION, REINSPECTION AND DECAL COST

WHEREAS, 16 G.C.A. §3602(a) enables the Director of Revenue and Taxation to make necessary rules and regulations for the administration and enforcement of vehicle inspections required under 16 G.C.A. §3601 et. seq; and

WHEREAS, 16 G.C.A. §3602(b), as amended by Public Law 18-30, authorizes the Director of Revenue and Taxation to establish and determine the fee to be charged for each such inspection; and

WHEREAS, the Administrative Adjudication Law requires an agency to hold public hearings before adopting a regulation; and

WHEREAS, a duly noticed hearing was held on April 21, 1986, at 10:00 a.m., in the Director's Conference Room, Department of Revenue and Taxation, to consider proposed amendments of regulations found in Title 23, Administrative Rules and Regulations, relative to increasing vehicle inspection fees from \$5.00 to \$8.00, and of reinspection fees from \$1.00 to \$2.00; and

WHEREAS, testimony was presented by the vehicle inspection industry at that hearing in support of the proposed increases and to the effect that the increase would well serve the industry and enable the industry to keep up with rising costs of the inspection industry; and

WHEREAS, in reconsidering the impact of the increased fees on the public, the Director of Revenue and Taxation determined that an increase in inspection fees to seven dollars rather than eight dollars would better serve the public interest, and that reduction in the decal cost from two dollars to one dollar would better serve the public interest; and

WHEREAS, such revision of the proposed fee increase from eight dollars to seven dollars for inspection, and the reduction from two dollars to one dollar for decals would also serve the interests of the inspection industry as represented at the public hearing; and

WHEREAS, I have determined that the proposed regulations as so revised are appropriate and should now be promulgated;

NOW, THEREFORE, I, RICARDO J. BORDALLO, Governor of Guam, by the authority vested in me by §3602 of the Government Code as amended by Public Law 18-30, and by the Organic Act of Guam, do hereby approve and promulgate the attached rules and regulations pertaining to vehicle inspection fees, reinspection fees and decal costs.
