EXECUTIVE ORDER NO. 91-14

ESTABLISHING THE GUAM ENERGY EMERGENCY  
ADVISORY AND PLANNING COUNCIL

WHEREAS, the Territory of Guam is 100% dependent upon imported fossil fuels for its energy needs for electrical power generation, transportation and the like; and

WHEREAS, shipping strikes, acts of God, fuel tanker disasters at sea, oil embargos, regional wars, sabotage on oil production facilities and the incidents of this sort would have an adverse effect on energy supplies worldwide and may result in a critical shortage of fossil fuels for the Territory of Guam to a greater extent than other jurisdictions, due to Guam's total dependence upon these fuels; and

WHEREAS, there is a need for an energy emergency advisory and planning body to better coordinate the disposition and use of energy resources in the private sector, military community, and the Government of Guam in the event of severe energy shortages; and

WHEREAS, there is, further, a need to lessen Guam's dependence on imported fossil fuels through the development of alternate energy sources including, but not limited to, solar, wind, biomass, geothermal, and ocean thermal energy conversion (OTEC); and

WHEREAS, the participation of a diverse, knowledgeable and experienced body of individuals from among the Guam community in an advisory capacity will better produce the most desirable recommendations on how to prepare for and manage possible energy emergencies;

NOW, THEREFORE, I, JOSEPH F. ADA, Governor of the Territory of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, do hereby order:

1. The establishment of the **Guam Energy Emergency Advisory and Planning Council**, to be comprised of representatives selected and appointed as follows:

One (1) representative from the Guam Energy Office, who shall serve as Executive Secretary;

One (1) representative each from the Guam National Guard, the Guam Power Authority, the Port Authority of Guam, the Guam Airport Authority, the Guam Mass Transit Authority, the Department of Public Works, the Bureau of Planning, and Guam Civil Defense, to be selected and appointed by the Governor;

One (1) representative from the Guam Legislature to be appointed by the Speaker among its members;

One (1) representative from the Guam Chamber of Commerce;

One (1) representative from the Guam Hotel and Restaurant Association;

One (1) representative from each of Guam's oil suppliers, including but not limited to Mobil, Shell, Exxon, PRI and PEDCO;

One (1) representative from the most senior regularly-scheduled airline company serving Guam to be selected and appointed by the Governor;


One (1) representative from Guam's independent retail service station outlets, to be selected and appointed by the Governor;

One (1) representative each from the United States Navy and the United States Air Force, to be selected and appointed by the Commander, Naval Forces Marianas and the Commander, Andersen Air Force Base, respectively;

One (1) member of the public-at-large, to be selected and appointed by the Governor.

2. The Council shall elect a **Chairman** and **Treasurer** among its membership at a scheduled meeting to be held for that purpose.
3. The Council shall meet periodically as needed and as called by the Chairperson or by one-third (1/3rd) of the total membership for purposes of information exchange, formulation of policy or recommendations to be submitted to the Governor for his review as well as to review and update--if needed the draft Government of Guam Energy Emergency Plan. Minutes shall be recorded at each Council meeting and written minutes shall be provided to the membership at the opening of each meeting. The meeting agenda shall be prepared by the Council Chairperson.
4. The Council is empowered to accept contributions in order to carry out its purposes and functions.
5. The Council shall adopt such rules as necessary to fulfill its responsibilities. All recommendations developed or adopted by the Council shall be submitted to the Governor for approval.
6. Executive Order No. 79-027 is hereby repealed and substituted with this Executive Order.
