EXECUTIVE ORDER NO. 91-28

EMERGENCY DECLARATION-GUAM NATIONAL GUARD  
SUPER TYPHOON YURI

WHEREAS, on the 26th of November 1991, a typhoon warning was in effect for Guam; and

WHEREAS, at approximately 1200 Hours, the 27th of November, 1991, Typhoon Yuri was located near Latitude 11.0 North, Longitude 148.8 East, approximately 180 miles South East of Guam; and

WHEREAS, winds near the center were 165 miles per hour gusting up to 200 miles per hour; and

WHEREAS, the forecast for Guam for Thursday, the 27th of November 1991, indicated heavy scattered showers with strong gusting winds; and

WHEREAS, at approximately 1200 Hours Wednesday, the 27th of November 1991, Governor Joseph F. Ada declared Guam under Typhoon Condition I as a result of Typhoon Yuri being located near Latitude 11.0 North, Longitude 148.8 East, approximately 180 miles East of Guam with winds of 165 miles per hour gusting to 200 miles per hour; and

WHEREAS, Typhoon Yuri was expected to pass within 50 miles of Guam at approximately 2100 Hours Wednesday, the 27th of November 1991; and

WHEREAS, the Governor is authorized, pursuant to Section 63500 of the Government Code Annotated, in time of any state emergency, to order the Guam National Guard, or any part thereof, into the active service of the Territory of Guam; and

WHEREAS, the Government of Guam, if it utilizes federal equipment and/or supplies, must reimburse the Federal Government for said use and must be responsible for any and all damages to said equipment; and

WHEREAS, the Governor is authorized, pursuant to Section 6113 of the Government Code, as amended by Section 4 of Public Law 15-75, to utilize any part or portion, not to exceed Two Hundred Fifty Thousand Dollars (\$250,000) of outstanding appropriations within the General Fund for expenses caused by civil defense, public safety or health emergencies; and

WHEREAS, department and agencies of the Government of Guam providing essential services of food, shelter, water, transportation, roads, electricity, safety and welfare of the inhabitants of Guam.

NOW, THEREFORE, I, JOSEPH F. ADA, Governor of Guam, by virtue of the authority vested in me by the Organic Act and Sections 6113 of the Government Code and Section 63500 of the

Government Code Annotated of Guam, do hereby direct and order as follows:

1. That there still exists an emergency affecting the health, safety and welfare of the citizens of the Territory of Guam as of 28 November 1991 as a result of Typhoon Yuri passing near Guam on the 27th of November, 1991, with winds of 165 miles per hour gusting up to 200 miles per hour.

2. That power outages and subsequent water outages/shortages as a result of Typhoon Yuri still pose serious and immediate threat to the health, safety and welfare of residents of the Territory of Guam on this 28th day of November 1991.

3. That members of the Guam Army National Guard assigned to the following unit and/or units are hereby ordered to active service of this Territory:

- A. 1224th Eng Det, HHD GTC
- B. 909th QM Det, HHD GTC

4. That the Adjutant General, with approval of the Governor, shall have the authority to call and/or activate other members of the Guam Air National Guard and the Guam Army National Guard, from any units needed, to perform missions assigned to the Guam National Guard by the Governor:

5. That the activated units and/or members are directed to:

Supply water to the villages and people of Guam as directed by Governor and/or his designee.

Provide assistance in road repairs and building repairs or other tasks as directed to be necessary for the good health and general welfare of the people of Guam by Governor and/or his designee.


The Guam National Guard is expected to accomplish the above missions while protecting the life, liberty, safety and health of the effected citizens of Guam and further protect all public and private property within the jurisdiction of the territory as set out in the mission above.

The Guam National Guard Military Commanders will take the measures and/or perform all those activities necessary to prevent, forestall or combat the effects of the emergency situation. Accomplishment of the above stated missions and the command and control of the command units are the sole responsibility of the Guam National Guard Military Commander subject to the statutory control of the Governor as the Commander-in-Chief.
