EXECUTIVE ORDER 93-01

**ESTABLISHING THE COORDINATING COMMITTEE
OF THE 1994 MICRONESIAN GAMES**

WHEREAS, Guam athletes represented the Territory with distinction at the XXV Olympiad in Barcelona, Spain, in 1992, in the 9th South Pacific Games in Papua New Guinea in 1991, in the South Pacific Mini Games in Tonga, in the XXIV Olympiad in Seoul, Korea, in 1988, in the 1990 Micronesian Games in Saipan, Commonwealth of the Northern Mariana Islands; and

WHEREAS, the reputation of Guam's tourism industry is enhanced by the existence of excellent sports facilities for international sporting events; and

WHEREAS, the nations of Micronesia have honored Guam in entrusting the island to host the 1994 Micronesian Games, a competition which would attract over 1,500 athletes from throughout our Micronesian region to participate; and

WHEREAS, the youth of Guam and Micronesia will benefit from the facilities improved for the 1994 Micronesian Games; and

WHEREAS, Guam must be prepared to present a plan for the hosting of the 1994 Micronesian Games to the Micronesian Games Council.

NOW, THEREFORE, I, FRANK F. BLAS, Governor of the Territory of Guam, Acting, by virtue of the authority vested in me by the Organic Act of Guam, as amended, do hereby create an organizing committee for the 1994 Micronesian Games to be hosted by the Territory of Guam. The Committee, to be called the Micronesian Games Organizing Committee, shall include, but not be limited to, the following membership:

The Speaker of the Guam Legislature, honorary co-chairman

The President of the Guam National Olympic Committee and Amateur Sports
Federation, Vice Chairperson


The Coordinating Committee shall directly be prepared for presentation to the Micronesian Games Council a plan for the hosting of the 1994 Games.

The Committee, which can establish subcommittees as necessary to complete its work, shall present to the Guam Legislature the Plan for the 1994 Games and encourage the support of the Legislature to appropriate funds for the renovation of athletic facilities for the 1994 Games.
