EXECUTIVE ORDER NO. 93-15

CREATING AND TEMPORARILY TRANSFERRING
ADMINISTRATION OF THE YOUTH CORRECTIONAL
FACILITY FROM THE DEPARTMENT OF YOUTH AFFAIRS
TO THE DEPARTMENT OF CORRECTIONS.

WHEREAS, the Department of Youth Affairs has custody of male youth who are being detained after being charged with crimes or have committed crimes which would have resulted in their incarceration in the Adult Correctional Facility except for their age; and

WHEREAS, the Department of Youth Affairs has requested assistance in establishing a Youth Correctional Facility for confinement of male youth who have been charged with crimes or have committed crimes which would have resulted in their incarceration in the Adult Correctional Facility except for their age; and

WHEREAS, growing serious criminal activity by male youth demands segregation of serious offenders from other male youth in the custody of the Department of Youth Affairs; and

WHEREAS, the Department of Corrections has the capability of assisting the Department of Youth Affairs in establishing the Youth Correctional Facility and in training personnel in administering the Youth Correctional Facility; and

WHEREAS, historically during the holidays the population of the Department of Youth Affairs increases requiring the immediate establishment of the Youth Correctional Facility;


NOW, THEREFORE, I, JOSEPH F. ADA, Governor of the Territory of Guam, pursuant to the authority vested in me by the Organic Act of Guam, as amended, hereby order that effective 6:00 a.m. November 9, 1993:

1. the Department of Corrections shall establish and administer the Youth Correctional Facility at the Department of Youth Affairs; and
2. only male youth who have been charged with crimes or have committed crimes which would have resulted in their incarceration in the Adult Correctional Facility except for their age shall be confined at the Youth Correctional Facility; and
3. the Department of Corrections shall erect such fences as are necessary in the Department of Youth Affairs compound to segregate buildings and open areas assigned to the Youth Correctional Facility from the rest of the compound; and



4. in accordance with 4 GCA §4117 there are detailed from the Department of Youth Affairs to the Department of Corrections any personnel requested by the Director of Corrections to assist the Department of Corrections in administering the Youth Correctional Facility or for on the job training at the Department of Corrections; and
5. the Departments of Corrections and Youth Affairs shall enter into a memorandum of understanding clearly establishing each department's responsibilities and authority and makes any arrangements necessary to implement this Order; and
6. the Department of Corrections shall transfer to the Department of Youth Affairs administration of the Youth Correctional Facility no later than 120 days from the promulgation of this order.
