EXECUTIVE ORDER NO. 94-18

**ESTABLISHING THE GUAM PUBLIC SCHOOL SYSTEM  
SCHOOL LUNCH REVOLVING FUND**

**WHEREAS**, the Guam Public School System operates a school lunch program and receives reimbursements from the U.S. Department of Agriculture; and


**WHEREAS**, the Guam Public School System wants to establish a revolving fund to account for the receipt and expenditures of these reimbursements; and

**WHEREAS**, such funds should be placed in a revolving fund to offset the expenses incurred in providing subsidized lunches.

**NOW, THEREFORE, I, JOSEPH F. ADA**, Governor of the Territory of Guam, pursuant to the authority vested in me by the Organic Act of Guam, as amended, and 5 GCA §22108, hereby order:

1. There is created the "Guam Public School System School Lunch Revolving Fund";
2. All funds collected from the U.S. Department of Agriculture, as reimbursement for subsidized lunches shall be deposited into said Fund;
3. Funds in the Guam Public School System School Lunch Revolving Fund may be used to purchase food for use in the School Lunch Program;
4. Said Fund shall be administered and maintained by the Guam Public School System and the Director is designated as the approving official for disbursements;
5. A complete and accurate accounting of all money deposited into and withdrawn from such Fund should be maintained by the Department of Administration; and
6. Such accounting shall include and clearly identify the sources and amounts of all funds paid into or withdrawn from said Fund.

AMENDING EXECUTIVE ORDER 88-19


**APPROVAL OF RULES AND REGULATIONS  
OF THE DEPARTMENT OF CORRECTIONS**

**WHEREAS,** the Director of Corrections, as authorized by 9 Guam Code Annotated, §90.30, has seen fit to adopt revised rules and regulations for the administration of the correctional institutions and other places of confinement; and

**WHEREAS,** these rules and regulations are needed for the efficient operation of the correctional institutions and for the treatment, care and reformation of the inmates thereof.

**NOW, THEREFORE, I, JOSEPH F. ADA,** Governor of the Territory of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, and in accordance with my authority under the above-cited statute, hereby approve, as attached hereto, the Rules and Regulations of the Department of Corrections for the Administration of Correctional Institutions and Other Places of Confinement, to be effective as of the date of signing of this Order.
