**EXECUTIVE ORDER NO. 97-33**

**CALLING UP SELECTED PERSONNEL OF THE GUAM NATIONAL GUARD TO TERRITORIAL ACTIVITIES AND DUTIES TO ASSIST IN IDENTIFIED PROJECTS REQUIRING HEAVY EQUIPMENT.**

**WHEREAS,** Executive Order No. 97-28 called up selected personnel of the Guam National Guard to Territorial Activities to assist with projects needed in the territory which required the use of heavy equipment, which the territory is lacking; and

**WHEREAS,** additional projects are needed by the Territory, and the Territory still does not have adequate heavy equipment to complete the projects; and

**WHEREAS,** the Guam National Guard is authorized to assist the local government in areas of mutual use to both the local government and in furtherance of the mission of the Guam National Guard ; and

**WHEREAS,** projects have been identified which are necessary to be accomplished by the local government and their execution coincides with the furtherance of the mission of the Guam National Guard; and

**WHEREAS,** the Governor is authorized pursuant to §63500 of Title 10, Guam Code Annotated, to order the Guam National Guard, or any part thereof, into the active service of the territory of Guam to assist the government of Guam in territorial activities and duties as determined by the Governor; and

**WHEREAS,** the government of Guam, if it utilizes federal equipment or supplies, must reimburse the Federal Government for the use and must be responsible for any and all damages to the equipment; and

**WHEREAS,** the Guam National Guard desires to provide heavy equipment and operators to further the training opportunities of the members of the Guam National Guard identified to assist in selected territorial projects;

**NOW, THEREFORE, I, CARL T. C. GUTIERREZ,** Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, and the laws of Guam, do hereby order the following:

1) **Projects requiring heavy equipment have been identified for completion.** Certain public works projects have been identified by the Guam Department of Public Works as necessary to be completed in the immediate future. Guam Department of Public Works is short of heavy equipment items which are in working condition and cannot complete them at this time because of this shortage, without outside assistance.

2) **Activated units of the Guam National Guard and duties.** Selected personnel of the following units are ordered to active service of the territory of Guam:

3) **Authority of Adjutant General to activate units needed.** The Adjutant General, with approval of the Governor, shall have the authority to call or activate other members of the Guam National Guard from any units needed, to perform missions assigned to the Guam National Guard by the Governor; and

The activated units or members are directed to provide heavy equipment including 3 dump trucks, 1 grader, and 1 roller for heavy equipment projects; and

The Guard will provide personnel as equipment drivers, observer passengers, and flagpersons, as well as a supervisor on hand; and

The duration of the projects to be completed should take no longer than Seventy-five (75) days.
