EXECUTIVE ORDER NO. 98-25

RELATIVE TO FORMING A TASK FORCE ON EARLY CHILDHOOD EDUCATION AND DEVELOPMENT.

WHEREAS, it is scientifically established that positive emotional, physical and intellectual experiences that a baby has in the earliest years, especially between birth and three years of age, are necessary for the growth of a healthy brain; and

WHEREAS, the repeated activation of these positive experiences provide the foundation for the infant's brain's organization and function in life; and

WHEREAS, it is recognized that sound and proper early childhood education and development has a direct relationship in all aspects of a society's continuing progress and strength; and

WHEREAS, Guam needs to develop a comprehensive strategy ensuring that early childhood education and development is a continuing and leading priority of both private and public policy; and

WHEREAS, Guam has numerous resources available to provide support for the advancement of early childhood education and development; and

WHEREAS, an early childhood education and development task force will be formed to address this major public and private priority; and

NOW, THEREFORE, I, CARL T. C. GUTIERREZ, I Maga lahen Guåhan, Governor of Guam, by virtue of the authority vested in me by the Organic Act of Guam, as amended, and the laws of Guam, do order:

- (1) An "Early Childhood Education and Development Task Force" is created, with members representing government agencies and the private sector involved directly and indirectly in early child care on Guam.
 - (a) The Early Childhood Education and Development Task Force consists of representatives from:
 - (i) Guam Educational Telecommunications Corporation (KGTF);
 - (ii) Guam Early Intervention System, Department of Education;
 - (iii) Early Childhood Education, Department of Education;
 - (iv) Head Start, Department of Education;
 - (v) Guam Association for the Education of Young Children;
 - (vi) Early Childhood Education, University of Guam;

- (vii) Child Development Center, University of Guam;
- (viii) Early Childhood Education Department, Guam Community College;
 - (ix) Bureau of Family Health and Nursing Services, Department of Public Health and Social Services;
 - (x) Child Protective Services, Department of Public Health and Social Services;
 - (xi) child care facility;
- (xii) Guam Memorial Hospital Authority;
- (xiii) community at large parents; and
- (b) The Early Childhood and Education Development Task Force has Four (4) missions:
 - (i) To serve as an advisory body on all issues, policies and other matters related to fostering a stronger early childhood education and development policy on Guam;
 - (ii) To develop an island-wide, public-private partnership plan to improve early childhood education and development;
 - (iii) To oversee the implementation of this early childhood education and development plan;
 - (iv) To report annually to the Governor and the Legislature on the current status of early childhood education and development.
