EXECUTIVE ORDER NO. 2010- 12

RELATIVE TO AUTHORIZING THE PAYMENT OF OVERTIME FOR THE DIVISION OF SENIOR CITIZENS, DEPARTMENT OF PUBLIC HEALTH AND SOCIAL SERVICES TO EXPEDITE THE COORDINATION, IMPLEMENTATION, AND MONITORING OF THE NECESSARY ACTIVITIES FOR THE UTILIZATION OF AMERICAN REINVESTMENT AND RECOVERY ACT (ARRA) OF 2009 FUNDS FOR THE PROVISION OF CONGREGATE NUTRITION SERVICES.

WHEREAS, the Department of Public Health and Social Services is in receipt of ARRA 2009 funding for Congregate Nutrition Services (Ref. Catalog of Federal Domestic Assistance: 93.707) to be expended no later than September 30, 2010; and

WHEREAS, the 2009 Congregate Nutrition Services Vendor's agreement did not appear to have the flexibility to allow for congregate meal services beyond lunch; and

WHEREAS, the Fiscal Year 2010 vendor agreement for Congregate Nutrition Services was effectuated with a new Vendor on February 1st, 2010; and

WHEREAS, the FY 2010 vendor agreement now contains the flexibility to provide lunch as the primary congregate meal service, with the option of congregate nutrition services at breakfast or dinner, subject to the availability of funds; and

WHEREAS, the Division of Senior Citizens is launching the *Manamko Breakfast Card* program that will allow congregate participants to obtain a balanced breakfast at approved congregate sites, primarily at our island's two Adult Day Care Centers and at Seafood Chef Restaurant; and

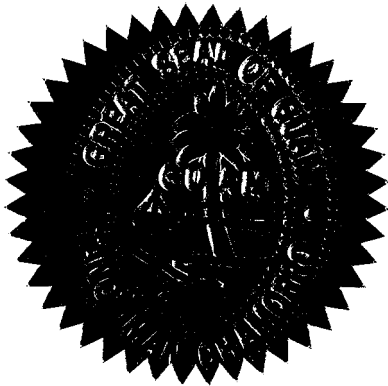
WHEREAS, the Department of Public Health & Social Services requires the use of additional man hours to plan, coordinate, and implement the expansion of this program;

NOW, THEREFORE, I, FELIX P. CAMACHO, *I Maga'lahaen Guåhan*, Governor of Guahan, by virtue of the authority vested in me by the Organic Act of Guahan, as amended, and the laws of Guahan, do hereby order that:



(1) **Authorization for Payment of Overtime.** In the event that it is necessary for the exempt or non-exempt employees of the Department of Public Health and Social Services to work in excess of forty (40) hours a week in order to expedite the coordination, implementation, and monitoring of the Congregate Nutrition Services Program as described above; the DPHSS director, may authorize that overtime work be performed as approved by the Bureau of Budget & Management Research (BBMR). All requests for approval of overtime shall include at a minimum the hours requested, the funding necessary, a description of the work to be performed and the names and titles of those who will be performing the work
